The need for 7.1ha of employment land has been identified. The allocated site of 8.7ha has been identified:

8.12 In terms of economic development, Chapter 4 (Employment) considers the matters of employment land supply and demand up to 2033. It is considered that there is no need to provide for additional employment land at Shaftesbury given the existing employment land that is allocated for development to the south of the A30. The site is currently being marketed and NDDC is exploring options for funding infrastructure on the site, in order to create serviced plots.

Persimmon are currently looking at applying for permission to build houses on the land.

We strongly object to any use for this land for anything other than employment. There is evidence that many of the local businesses want to expand and stay in Shaftesbury. Without developing this land for employment, new businesses would have to go to neighboring towns and existing businesses would need to relocate away from Shaftesbury.
