5.1.3 FOR "STALBRIDGE AND THE VILLAGES", LPP1 STATES "825 DWELLINGS WILL BE PROVIDED DURING 2011 - 2031." THIS EQUATES TO APPROXIMATELY 40 PER YEAR, WHICH SEEMS REASONABLE.

10.1.8 "DEVELOPMENT IN ALL AREAS WOULD SUPPORT TOWN CENTRE REGENERATION" - HOW ?

14.2.3 "BY INCLUDING STALBRIDGE AS A LOCAL CENTRE AND DIRECTING RETAIL USES TOWARDS THIS TOWN CENTRE" - AGAIN, HOW ? OVER THE LAST 3-4 YEARS, MANY OF THE HIGH STREET BUSINESSES HAVE CLOSED AND THE PREMISES HAVE BEEN CONVERTED TO FLATS. FURTHERMORE, THERE APPEARS TO BE LITTLE OR NO SCOPE IN THE TOWN CENTRE AREA FOR ANY NEW RETAIL USES.

14.2.6 "IT IS MORE LIKELY THAT RETAIL USES WILL OCCUPY THE EXISTING VACANT UNITS" - NOT SO. IT IS TOO LATE. MOST OF THE UNITS THAT HAVE BECOME VACANT HAVE BEEN CONVERTED TO FLATS. ALSO, WHILST THE SUCCESS OF MIKES SUPERMARKET IN RECENT TIMES IS A WELCOME BENEFIT TO STALBRIDGE, THE DOWNSIDE IS THAT PROSPECTS FOR THE SURVIVAL OF ANY NEW RETAIL USES THAT MAY START UP WOULD BE VERY BLEAK.
